Cotton Winter Nursery Relocation <sup>1</sup> – I have been working with Don Jones, Cotton Inc, and Richard Percy, ARS, to relocate the CWN to northern Costa Rica. Last summer we hired Alfonso Palafax as the nursery manager, who had been the assistant manager in Mexico. In early September we visited Costa Rica and arranged with Bayer Crop Science to use some of their land to plant a small-scale nursery for the 2015-'16 season. Don, Richard and I visited the nursery this February and the plants look very healthy, although somewhat small due to late planting. Unmanned Aircraft in Agriculture <sup>1</sup> – During the fall SAAESD meeting, a discussion on unmanned aircraft use in agriculture resulted in a decision by the directors to facilitate development of a multistate research project in this area. In order to gage interest among faculty in this field, I held a conference call in November with 15 faculty representing 12 southern institutions. The faculty on the call expressed great interest in moving forward. To begin the planning and proposal development process, a meeting was held in Atlanta with 27 faculty representing 14 southern institutions. Ten of those faculty are currently coleading four writing groups to finalize the objectives chosen and supporting information. A conference call with the 10 co-leaders will be held in mid-April.
