# MRC Report September 9, 2010

#### **Current Status:**

The Southern MRC is composed of Ed King (ARS Rep), David Morrison (Chair), Craig Nessler, Clarence Watson, Steve Workman, and Eric Young. Since the 2010 Spring Meeting, there have been seven (7) MRF activities requiring MRC review. The SDC336 proposal was approved as S-1047, the SDC333 proposal was approved as S-1048, the SDC339 proposal was approved as S-1049, the SDC338 proposal was approved as S-1050, the SDC340 proposal was approved as S-1051 and the S\_temp2382 proposal was re-approved as SCC-33. In addition, for the first time during my tenure as MRC Chair, the committee disapproved a proposal. The SDC335 proposal lacked sufficient research specificity and depth and upon MRC recommendation, the proposal was re-submitted as S\_temp2442 and subsequently approved as SCC-83. The MRC continues to encourage AAs to provide SDCs with copies of Appendix H (the MRC Evaluation Form), which will alert these committees to the evaluation criteria being used by the MRC. This should help facilitate an increase in the number of proposals approved after initial MRC review.
